




interest in green funeral options: according to NFDA's 2023 consumer awareness and preferences report, 60% would be interested in exploring "green" funeral options because of their potential environmental benefits, cost savings or for some other reason, up from 55.7% in 2021.

### Why Did We Get Here? Consumer Trends

#### 2022 Annual NFDA Consumer Study Findings

When planning their own funerals, 21.0% of consumers age 40 and older would prefer a casketed burial; 11.5% would prefer a "green" burial; and 16.0% are "not sure" or "undecided" about choosing burial for their final disposition.

Of the 41.8% of consumers who would prefer cremation, 25.9% said they would personally wish to have a complete funeral service with a viewing and visitation prior to cremation.

## The Unique Challenges of Our Times

#### Reasons to Cremate or Bury Green

Many factors contribute to the steadily rising selection of cremation by U.S. consumers, including cost considerations; environmental concerns; an increasingly transient population; fewer religious prohibitions against the practice; and changing consumer preferences, such as the desire for simpler, less-ritualized funeral ceremonies.

In addition, cremation has become socially acceptable as a growing number of Americans think and talk about death in new ways. Cremation's popularity is only expected to increase.

## Reasons for Cremation and Green Burial What We are Missing

- American Society, more than any other in the world, does not know how to deal with death
  - Cremation provides a quick solution, allowing the family to postpone the reality of death, essentially denying or delaying it
  - Excuses like waiting for a better time for the ceremony, giving the immediate family time to process, and not wanting to make a "big deal" of the death, lead to a potential delay in the grief journey
- Natural Burial addresses the finality issue, but can still be completed with little or no ceremony

### Reasons for Cremation and Green Burial What We are Missing


- o 48% of Americans do not have life insurance and less than one third of Americans have pensions. Furthermore, 33% of Americans have no money saved for retirement!
  - THESE WERE THE TRADITIONAL FINCANCIAL SOURCES FOR FUNERAL AND MEMORIAL PURCHASES
  - MANY AMERICANS ARE LEFT TO FUND THE FUNERAL AND MEMORIAL OUT OF THEIR OWN POCKETS
- o People do not want to spend estate monies on the deceased, they want to spend it on themselves. We are becoming a "ME" society.







Cremation is a Final Disposition

#### The Problem on Cremation as Final Disposition


- According to a recent article published by CANA, deciding to keep or dispose of a cremated body "without funerals or memorialization of any kind can cause serious traumatic problems for survivors." Furthermore, death care providers "have noticed signs of severe emotional stress among the survivors in instances of cremation without memorialization... Many psychiatrists feel that the funeral serves a very real need for the survivors."
- Nearly 30 percent of cremated bodies are being kept in the home, partly because families don't know what else to do.











#### MISCONCEPTION 2

Memorialization serves no purpose and is outdated

#### Why Memorialization Matters

- Allows for closure, not just for immediate family, but also the grieving community of relatives and friends by acknowledging the reality of death
- Creates a communal environment to process death as a fellowship, combating grieving isolation
- Helps grievers pass through the stages of grief in a natural order and lets them know they are not alone
- Preserves and perpetuates memories and stories for future remembrance and genealogy
- Provides a physical place to process loss and remember

"When everyday words and actions are inadequate, the ritual of ceremony provides a needed structure of what to say and do. Funerals also help us acknowledge the reality of the death, remember the life that was lived, support one another in our grief, express our grief outside of ourselves, consider the meaning of life, and begin the long, hard process of coming to transcend our grief and move toward a new wholeness."


#### MISCONCEPTION 3

  - Informal Settings over Churches or Funeral Homes
  - Focus on a Life Well Lived over Death and Loss

  - Tropical set up in a funeral home staging the deceased in a chair under a palm tree
  - Man placed in his easy chair in his favorite team's colors with a game on the TV
  - Man buried riding his motorcycle























#### Key Takeaways
